ANIMAL CONTROL AGREEMENT

BETWEEN: **THE CORPORATION OF THE VILLAGE OF ALERT BAY**
(Hereinafter called the "Corporation") **OF THE FIRST PART**

AND: **'NAMGIS FIRST NATION**
BOX 210
ALERT BAY, B.C. V0N 1A0
(Hereinafter called the "'Namgis") **OF THE SECOND PART**

WHEREAS the parties have agreed that the Corporation will provide Animal Control Services to the 'Namgis in accordance with Village of Alert Bay Animal Control Bylaw #737, 2010 and any subsequent bylaws.

NOW THEREFORE this agreement witnessed that in consideration of the premises, mutual covenants and agreements herein contained, the corporation and the 'Namgis covenant and hereby agree as follows:

1. The Corporation and the 'Namgis agree that the terms of this agreement will be in effect from year to year, commencing January 1, 2013 and ending December 31st, 2013, the option for renewal on January 1st of each year thereafter, but may be cancelled or re-negotiated by either party upon one month's written notice to the other party.
2. The 'Namgis agrees to pay \$9,675.00 per annum to the Corporation in consideration of providing this service, based on a per capita cost-sharing arrangement between the 'Namgis, the Village and the Whe-La-La-U Area Council.
3. The 2011 'Namgis share is based upon a population of 750 people, a number to be adjusted annually based on the 'Namgis population as of December 1st of each year.
4. The 'Namgis agree to enact a animal control Bylaw similar to the Corporation's Bylaw.
5. Assistance with other special costs of dog control as may be requested from time to time.
6. This agreement and terms and conditions herein shall endure to the benefit of the parties as well as their successors and assigns respectively.
7. The Corporation agrees that each year after the yearly audits have been completed a copy of the revenues and expenditures for the Animal Control function shall be provided to the 'Namgis.
